has contacted Dean Johnson, from Resource  
Strategies and he said maybe around  
\$3,500 should do this

A resolution needs to be done further. Greg Langer has the papers to apply and made the motion to have this done. Dave Raehl second. Approved. Greg will take this to the County as it needs to be in by Feb 28th.

Bruce Anderson has contacted Greg Langer asking about Paul Fjellsted property & remaining Marquette Hauberg property to put a development on this. He has asked before. This is not an option at this time.

They has purchased (Color) cartridges for copy machine. \$212.00. Richard Moore moved that they be paid for. Dave Raehl second. A check will be written.

Snow banks were discussed. Will move the biggest ones (5-6 places) to make room for more. Bryce Otte said he would check this out.
