

The Greenville Town Board met June 21, 2012 at 7:00 p.m. at the town hall with all members present.

The meeting was called to order by chairman Robert Winter and the pledge was said.

The clerk read the minutes from May. Dave Raehl moved to accept and Richard Moore second. Approved.

Terry Mulligan had a subdivision drawn up for his Mother (Luella) property, 3 acre for Ken Langeslag. Mr. Langeslag want build a garage but wants to go closer to side property line. Terry is OK with this and will do a variance to allow this. 30' instead of 50'.

Lianda Dally came before the board with a concern. Her Lawyer interpreted that she has a building permit on Peesky property. Will contact Victor Valbut on this. As he had the paper drawn up on his property.

Myron Langenfeld and Faye Merritt from the real estate agency. came before the board again for 9 acres along 19 with the request for building a church. Board decided we should have a public hearing to give residents a chance to hear what

is being requested. This will be set for July 5 at 7:00 pm at the town Hall, we will send out notices.

Chad Patton came before the board with a request to build a barn on Jerry Patton's property, but will be close to Larry Patton's property line. Larry is O.K. with this & will grant a variance. Will be 100' from road. Shed will be 24 x 28'. Will get a permit when ready.

Bruce Mohn came before the board with a concern. He has 30 acres in Greenville. He would like to transfer his building site to Alan Mohn. When Jim Reisinger came before the board it was decided these two properties were lots of record before the 1 in 40 come into being. 10 from Dave Stanton and 30 from Martin Mohn. the ~~board~~ ^{board} said this was O.K. If done papers would have to be drawn up.

Bryce Ott has been working on roads that have washed out with the big rains we had. 9" in a couple days. He and Halvok & also some bridges & culverts. Roads had been barricaded. Graveling will start in about a week. Richard Moore will take samples and have Dakota Co. test it for quality.

Joe Kalina had a concern about 9 acres next to him. Water & such. Linger Langer also had some. Non-homestead Ag Land. Told to come to public meeting.

Bruce Atte had some concerns about
 driveways washing into roads. He
 said some township cost share with
 homeowners for driveways. Some
 concerns are. Prescott driveway,
 Benalben, stables, Baltus culverts,
 Isle, 305th. He will get some
 figures together & bring to next meeting.
 Culverts should be 16" minimum.
