Five \$17,000 was asked for. Five Department sets this & is staying the same. Bernard Budin moved to raise \$17,000 Wayne Peterson second motion Approved

Money to be raised to pay bond for town hall is \$35,000. This is a 10 year levy. & this will be year #3. Eric Christensen moved and Joe Lure second Approved.

Old business - Planning Commission was brought up as an unfinished project. Did some checking and some use but not real often. Will try & get this set up this year.

new business - Transfer to Senks property from Soresma was brought up and people wondered if land is gone is there still rites left. Will that effect the 1 per 40 quota.
