Barb Ohmann came to table to help interpret map. Victor remembered 2 came from over by Trahan's. Barb remembered there was a trailer house... Victor remembered Fridgen wanted to but did not separate 2... #2 transferred to section 10, #1 txn to sec 10, #3... Langer will take notes and with approval consolidate for review by rest of group.

Old Town Hall site has right because there is a full QQ section. Let's remove asterisk. Next Q has young Hermann, next one over is Bob Mahowald. Langer said it looks like there are 2 & one maybe... Victor thought that would be a definite/not maybe. Clerk noted news Ohmann's are going Organic with dairy.

Gehlers issue was discussed further a bit and Fredrickson said we should not let it keep bugging them.

Section 17: Mark Malecha's FNAP application is maybe approved at County. Roehl asked if from last meeting we have docs from Eric with transfers from Malechas? Victor asked about Rowans selling off 3 lots? Are they in FNAP?

Langer moved for next meeting to be Tuesday November 3rd. Fredrickson seconded and Motion passed.
