Clerk was called on to read the  
minutes from September. Greg Lanqu  
moved to accept Richard Moore second

Business for the meeting was  
follows.

property and haul clay back. Will haul  
on Evelett.

Greg Lanqu pulled a little off the  
web on a hold up on Windmill  
plans for now. Want to get more  
enformation & submit a new plan  
Greg Lanqu drafted a letter to be

sent to Public Utilities Commission stating the town board is not in agreement with the plan as it was proposed by the Medin & Spahr families.

Greg Lanque moved to sign and send to P.U.C. Richard Moore second. Clerk will check with Bob Winter, tomorrow

Inspection fee for Bob Hegner on wind tower plan was discussed. There is no contact with the engineer. On shul there was \$100.00 plan ~~planned~~ application and \$6000.00 plan review for Bob Hegner. Clerk was instructed to draft a letter or call Dave Medin to try to get this resolved. 2 checks will be signed so clerk can finish before next meeting. Return Medins check - Cash medins check or what?

Greg Lanque brought up Scott Narkunas driveway. No easements on Denny or Braun property. Scott was land locked when he built his house. Options - petition township for a cutway. Township declare a minimum maintenance road. Greg will check with township association attorney again. May need appraisal - survey - hire attorney

or maybe even go to court and let a judge decide. As land lay now Scott could maybe build a new driveway but that would be very costly. This is due to some land transfer. Options to buy land on Brauns side & move driveway a little.

Town hall site was discussed. Otis have given a bid for \$1500 to clean up cement & level property.

Dave Rache can take some debris & haul off also. Call Aimee Nelson for remainder of wood shed. Will get site cleaned up and maybe sell to Ohmans or something.

Richard Moore brought up culvert on 285th & Garritt by Henrys. seems to not be running right. Supervisors will check this with Otis & repair.

Trees on Richard Lacin road are a concern as hanging over road. Hazard to trucks & machinery moving on this road. Otis will cut & trim these soon. Works best when leaves are off.

Joint Powers Agreement for County to name roads if new ones are

made, such needs to be passed & signed. Greg Lanque made a motion & Richard Moore second. Approved. Sign & return to County.

Let a notice from Dean Johnson to put in the newspaper for Comprehensive Plan.

Discussion as to fee for using town hall. Suggestions were township business, no fee \$250.00 damage deposit with a portion being refunded if left in good shape when done. Supervisors will check with other townships & report back.

Greg Lanque asked if meeting times could be changed to 7:00 PM. Will discuss next time.
